Financials

Fundraising account is sitting at \$1754.96, Main account is sitting at \$97,665.62, ice for January has come out, no Feb invoice from refs yet, Myers is working on it, \$1100 U8 and both U13LL teams sent for wrap up jamborees, reimbursement to AMC for shooter tutor, and GLI promotions for sponsorship banner, ice rental for U13's paid, Anthony Tapper and Lacey Clement all up to date, Leo League fine paid, wheelhouse jersey reimbursement, Murray Law invoice paid for the incorporation stuff, all books are now posted, Mike (accountant) is going to look at them to ensure everything has been allocated

correctly, then she can pull reports, etc., once this is complete then she will issue receipts to all the sponsorships and hand them out at next meeting to Jeff. She is still watching to verify a couple of cheques - still some pending. Everything paid and up to date. The raffle ticket money is still in the main account, she hasn't transferred over yet, will do that soon as has to meet with Sadie for amount. Feb and March ice to still pay, so another roughly \$30,000.00.

New/Other Business

- Early try outs parent representatives at meeting and by notes brought up the fact that Stirling is doing spring tryouts, what are the pros and cons to this, Pros: we could do a fundraiser for tryout fee coverage, we would have a drawing card to increase the numbers, teams would have more practice time over the summer, these spring tryouts would be to compete with other centres, completing bio post on website to attract players, Cons: we potentially will have left over players, costs may differ for players, we may loose players. Is there any way we can convince the town to put ice in at end of August ice is terrible in September I don't think the municipality will be able to get the ice in then, we may have to rent a block somewhere else, but this may change with the next subject
- Discussion on Amalgamation members of the executive have been having conversations with CHMHA about amalgamating – the reasons for the discussions came up due to unhappiness of some kids and some of the problems that occurred this fall. Discussions were based off of increasing the number of kids we have for team selections and placing kids on the right teams for development reasons. Preliminary conversations consisted of individual talks and then a zoom call last night with some TMHA and some CHMHA executive members (Crystal Julia, James McConnell, Josh Moore, Jeff Newman and Catie Gordon), we all agreed this would make us be more competitive and put kids where they need to play (when we don't do this we have frustrated kids and kids not getting proper development), formal amalgamation is the cleanest way to do this but this had to have approval in November of 2024, the CHMHA exec has looked into this type of stuff previously as they are in the same boat as us being a small town centre, James reached out to OMHA (Suzanne) earlier to discuss this topic and that they weren't sure they would be allowing any amalgamations at this point due to some ongoing things, Josh brought up the on going things, which is a pilot project that OMHA put out as well that could effect us in the long run "New WOAA "A" zones" (Catie handed out an article on this), we discussed more about an informal agreement that could work between both centres, this would involve a sub-committee to figure out how we operate, we discussed things like: each centre has certain teams (if CHMHA had U11, then TMHA would not offer U11, etc.), there would be more ice time with 3 arenas to get ice from, we would have to look at costs of registrations – they would need to be the same and open our stores at the same time, jerseys do we buy still – we are thinking yes (could do rentals for ones who just can't afford it), there are a lot more things to go over but this is the basics of the movement, Jeff puts forward a motion to develop a sub-committee to do the framework and build a pilot project proposal and we present to both executive teams - 5 yes, 0 no, who does the sub committee - we thought this should be 3 people from each executive, Jeff to reach out, Catie suggested she could, a few thinking about it, it was suggested in our zoom meeting these people need to be able to make time for this as this is hopefully going to be

completed within 2 to 3 weeks time, so if you don't have the time for it then it is not a good avenue to take on
